The application requires all of the following information...

- Length of time needed (Due to continuing education credit processes, all sessions must be a minimum of 60 minutes. Including time for Q/A.)

The deadline for submissions is **Monday, September 30, 2019 at 6:00 pm**, so please get your presentation ideas in as soon as possible. The Planning Committee will select and notify presenters in early-December. Selected presenters will then submit a signed agreement provided by the PAEP office to confirm their arrangement. Presentations can be 60- or 75-minutes in length including time for Q/A from the audience. If you need more time, please let us know as we may be able to accommodate this.

EXPENSES: Registration is free for all conference presenters on the day of their presentation. Presenters will be required to pay for attendance to supplementary conference events (such as the Annual Banquet, Short Course, etc.) or to attend additional days of the conference beyond the day of their presentation. The presenter is also responsible for all other expenses related to travel, hotel, and non-conference meals.
