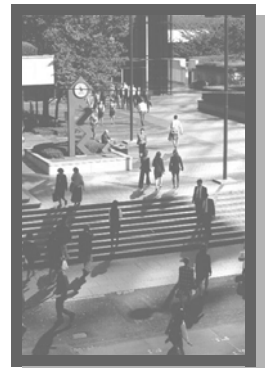

Pennsylvania Environmental Heritage Program

The Pennsylvania Environmental Heritage Program is off and running. On Thursday, February 27, 2003, PAEP Environmental Heritage Program Committee members Wayne Kober and Bob Hosking met with USDA Forest Service Education and Outreach Specialists Lori McKean, Chuck Croston and Lynn Dennis at the recently restored National Historic Landmark Gray Towers, located in Milford, Pennsylvania. The purpose of the meeting was to introduce the Pennsylvania Environmental Heritage Program to the Forest Service's Gray Towers interpretive staff, and to solicit their support and participation. The meeting was a success in that the staff expressed their enthusiasm for the Pennsylvania Environmental Heritage Program, and pledged to participate in our April 30th through May 2nd Annual Meeting by contributing an exhibit, and attending the Friday's May 2nd special workshop session. The meeting also included an interpretive tour of Gray Towers, the chateausque summer mansion built in 1886 by James Pinchot, the father of Gifford Pinchot, and later served as Gifford Pinchot's legal residence.

Gifford Pinchot, the first chief of the USDA Forest Service, is widely regarded as the founder of the conservation movement in America, which is based upon the principle of "the greatest good for the greatest number in the long run". Concerned about destructive lumbering practices, Gifford's father James helped found the American Forestry Association, and encouraged Gifford to pursue a career in forestry. Gifford attended Yale in 1885. Although forestry schools did not exist in the United States at that time, he took whatever related courses he could. After Yale, Gifford attended the French Forestry School in Nancy, France, but he left after his first year of study to confront the devastating forestry practices that had become widespread in the United States. After becoming Chief of the Division of Forestry in 1898, Gifford found that both trained foresters and schools with significant forestry programs were in short supply. In 1900, Gifford persuaded his parents to endow Yale University with \$150,000 to start the Yale Summer School of Forestry, a post graduate program which operated on the grounds adjacent to Gray Towers from 1901 to 1926. Gifford Pinchot and Theodore Roosevelt were best friends, so during his tenure as Chief of the Forest Service our national forests tripled in size to 193 million acres. Gifford Pinchot is largely credited for making conservation Theodore Roosevelt's greatest contribution to American domestic policy. Pinchot himself was successful at politics, elected Governor of Pennsylvania in 1922 and again in 1930. In addition he was a prolific writer, authoring numerous books including his landmark autobiography "Breaking New Ground".

Gifford Bryce Pinchot, the son of Gifford and Cornelia, donated Gray Towers and 102 acres to the USDA Forest Service in 1963. On September 24, 1963, President John F. Kennedy dedicated the Pinchot Institute for Conservation, a national, non-profit group committed to leadership in forest policy, thought and action. Today, conferences and seminars at the Gray Towers estate bring together a diversity of leading conservation and environmental leaders to help guide the future of natural resource conservation. To learn more about the Pinchot Institute for Conservation and Gray Towers National Historic Landmark, visit their web site at www.pinchot.org.

Better yet, when you get a chance to visit northeastern Pennsylvania, make it a point to visit Gray Towers, located west of Route 6, just north of the intersection of Route 209 and Route 6 in Downtown Milford.

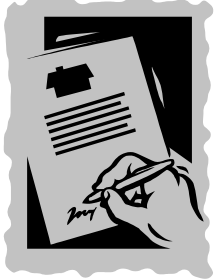
Bog Turtle Habitat Identification Training



The US Fish and Wildlife Service and the Pennsylvania Association of Environmental Professionals have joined forces to offer a training course in Bog Turtle Habitat Identification. The goal of this training is to help educate environmental professionals who are interested in conducting Phase I Bog Turtle Habitat Surveys in Pennsylvania. This notice is intended as a survey to find out whether or not there is sufficient interest for us to hold this training program here in Southeastern Pennsylvania. We ask that you carefully review the information provided below. If you qualify and are interested in this course, please notify us by sending your contact information to Elaine Farrell (Email: efarrell@farrell-assoc.com), to be put on our list. It is our hope that this training course will enhance the ability of environmental professionals to conduct these studies, which are important to identifying and protecting bog turtle habitat.

- This training course is being developed for environmental professionals who routinely conduct wetland studies or other biological assessments.
- The registration fee for this course has initially been estimated at \$500.
- As a minimum, candidates should have a Bachelor's Degree in Biology or similar environmental field of study and five years of field experience in wetlands or biological studies/investigations.
- We anticipate that a total of six days will be required for this training program, including two days in a classroom and four days in the field.
- This training course would likely be held in the Fall of 2003 (4-days), with additional field time being required in the Spring of 2004 (2-days).

On January 9, 2003, the Western Section of PAEP held it's largest event ever, with nearly eighty people in attendance. The program detailed the accomplishments of PADEP's Growing Greener Program, and was highlighted by a presentation by former PADEP Secretary David E. Hess.

"Nearly 1,100 watershed groups, authorities, local governments and county conservation districts have helped clean up our Commonwealth's waterways, reclaim mine-scarred lands, reduce acid mine drainage, plug abandoned gas wells and reduce nutrients coming from farms -- all thanks to the Growing Greener program," Secretary Hess said. "I have seen these accomplishments first-hand and the pride people take in making their communities better in my travels to every county in Pennsylvania."

In addition to Secretary Hess, Tim Danehy of Stream Restoration Inc. spoke about the benefits of Public/Private partnerships in his work with Acid Mine Drainage treatment, John Schombert of 3 Rivers Wet Weather

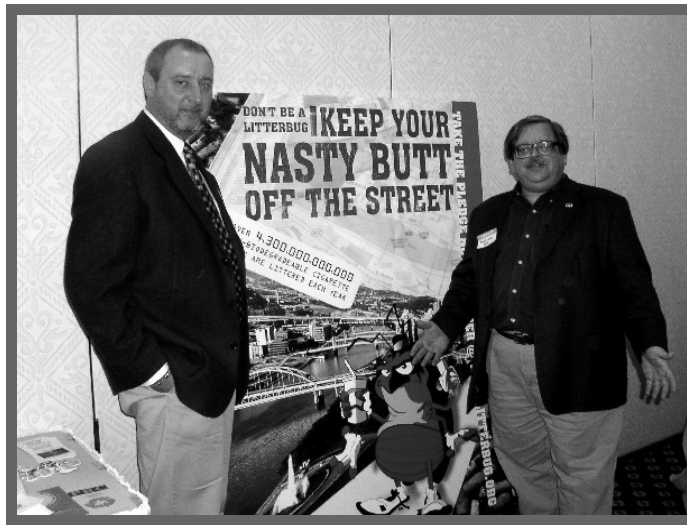
Demonstration Project spoke about the support the project has received from Growing Greener, James Mondok from the Mercer County Conservation District spoke about watershed activities in the Shenango River Watershed, and Joe West of the Beaver County Planning Commission spoke about the Brady's Run Streamband Stabilization Project.

Along with the speakers, there were many poster presentations from non-profit organizations, watershed groups, and conservation districts that have received Growing Greener funding.

On March 12, 2003, the Western Section held a program entitled, "Protecting Pennsylvania's Streams and Wetlands: Guidance on the Pennsylvania State Programmatic General Permit – 2 (PASPGP-2) and Isolated versus Non-Isolated Wetlands". Representative of the USACOE and PADEP spoke about this important topic.

Plans are in the works for a program on the NPDES Phase II process, a bus trip to the windmills near Somerset, PA, and a tour of a Hazardous Waste Incinerator.
