Walter Lyon Appreciation at the Pennsylvania State Archives

The Pennsylvania State Archives honored noted civil engineer Walter Lyon for donating his personal and professional collection at a ceremony and reception on March 12, 2007. Hosted by the Pennsylvania Heritage Society, several of Lyon's colleagues and friends, as well as Pennsylvania Historical and Museum Commission (PHMC) staff, attended the event at the State Archives facility in Harrisburg. PHMC Executive Director Barbara Franco and State Archives Bureau Director David Haury presided at the ceremony, which also included remarks by environmental historian Vagel Keller and Pennsylvania Association of Environmental Professionals Conservation Heritage Committee Chair Wayne Kober.

The Walter Lyon Papers, Manuscript Group 472, have been processed and are open for research at the Pennsylvania State Archives. Lyon generously donated the bulk of the collection in 2002, which contains over one-hundred archival boxes of materials relating to his life and work. Lyon was a civil engineer who held a variety of administrative positions in both state and federal government from 1950–1983. Born in Cologne, Germany, in 1924, he immigrated to the United States during childhood and served in the U.S. Army during World War II. After the war, he received a bachelor's degree in Civil Engineering and later a master's in Sanitary Engineering, both from The Johns Hopkins University. Eventually Lyon came to work for the Commonwealth, holding a number of civil service posts during a crucial time in Pennsylvania's, and the nation's, environmental history. Most notably he served as the director of the Bureau of Water Quality Management, under the old Department of Environmental Resources, from 1971–1979. In addition to heading the water pollution and drinking water programs during his tenure with the commonwealth, Lyon was responsible for overseeing the state's Environmental Master Plan, as well as Pennsylvania's Recreation Plan. He was also involved in federal environmental and resources legislation and policy analysis before his retirement from public service in 1983. Since then he has taught several Systems Engineering courses at the University of Pennsylvania, and served as a consultant in environmental engineering and water resources for various public

various public and private organizations.

The Pennsylvania Heritage Society is a non-profit organization supporting the Pennsylvania Historical and Museum Commission (PHMC), the official state agency charged with preserving and interpreting the Commonwealth's heritage and culture. The Pennsylvania State Archives is a bureau of the PHMC and is the official custodian of the permanently valuable records of Pennsylvania state government as well as a repository for papers and records of individuals and families, businesses, and organizations that have statewide historical significance.
