# Karl Mason Project

The Pennsylvania Association of Environmental Professionals (PAEP) presented the 2009 Karl Mason Awards during their Annual Conference on May 14, 2009. The 2009 awards were presented to Devra L. Davis PHD, MPH, who received the award in the individual category, and Montour Run Watershed Association, recipients of the award in the organization/project category.

#### Who is Karl Mason and what is the Karl Mason Award?

Karl Mason served as Pennsylvania's first State Environmental Administrator from 1952 until his death in 1966. Karl's holistic vision of environmental management set the pattern for the state to this day. Karl believed and put into practice the notion that environmental protection is primarily the business of professionals who have the skills by virtue of their scientific training to manage the technical and scientific complexities of maintaining a safe, healthy and clean environment.

The Award was created to commemorate his vision of a strong, well-managed environmental program. Stewardship of the Karl Mason Award rests with PAEP, but anyone may submit a nomination to the Association.

The Award is given to a Pennsylvania person, organization, or project that has made a significant contribution to the betterment of Pennsylvania's environment, exemplifying Karl Mason's vision.



**PAEP** continues to maintain stewardship of the Karl Mason Award. Each year, at the PAEP Annual Meeting and Conference the Karl Mason Award is presented to meritorious nominees selected by the Board from two general categories:



#### LEGAL/REGULATORY INFORMATION

#### RENEWABLE FUELS

Endangerment Finding: On December 15, EPA published its long-awaited Clean Air Act (CAA) Section 202(a) endangerment finding with respect to the six most critical greenhouse gases (GHG). See 74 Fed. Reg. 66496 (Dec.15, 2009). This finding is a pre-condition for further carbon emission reduction regulation under the CAA; but does not commit the agency to any specific strategy or timetable.

The endangerment finding reflects both the legal and political agendas being imposed on EPA. First, is the Supreme Court's 2007 ruling in an environmental interest group law suit, holding that GHGs are air pollutants under the CAA and requiring EPA to evaluate the endangerment posed by GHGs. Second, is the President's plan to create regulatory momentum on climate change issues which will motivate legislative action and/or create a foundation in the absence of legislative will. There are many, on the Hill and elsewhere, who are still not convinced that carbon emission reduction is necessary to prevent global warming. Nevertheless, the Federal Register notice and extensive supporting documentation will likely be an important component of the climate change discussion in the immediate future.

GHG Reporting: Beginning December 29, GHG reporting rules kick in for emissions of 25,000 or metric tons of CO2 equivalent, within 30 source categories identified by EPA in its October 29, 2009 rulemaking. See, 74 Fed.Reg. 56260 (Oct. 30, 2009). Included on the source list are electric utilities, petroleum refineries, petroleum product suppliers, glass manufacturing, iron and steel production, cement production, pulp and paper production, and municipal solid waste landfills. Notably, ethanol production was removed from the final list of applicable industries.

<u>PA Climate Change Action Plan:</u> Many states have also been busy addressing climate change, with alternate energy portfolio requirements and blueprints for regulatory change to reduce carbon emission. Pennsylvania took a large step forward on December 18, 2009, with the publication of a 793 page Climate Change Action Plan. This report was compiled by PADEP, with substantial input from a Climate Change Advisory Committee, in response to requirements set forth in the Pennsylvania Climate Change Act of July 2008 (Act 70).

A key target recommendation of the Plan is to reduce GHG emissions to 30% below year 2000 levels, by year 2020.

#### STORMWATER REGULATION

On December 1, EPA promulgated regulations imposing specific best management practices on construction activities that require an NPDES permit. See 74 Fed. Reg. 62996 (Dec. 1, 2009). By definition, this applies to disturbance of 5 acres or more. Most of the new requirements, including soil stabilization and erosion/sedimentation controls, are applicable by February 1, 2010. New Turbidity limits are also imposed on disturbance of 10 acres or more, with phase-in dates of August 2, 2010 and February 2, 2014 for disturbance of 10 or 20 acres or more, respectively.

#### What's in the News....

#### Karl Mason Award Winner Accomplishes Several Goals Improving Montour Run Watershed and Its Communities

The Montour Run Watershed Association (MRWA), recipient of the Karl Mason Award in 2009 from the Pennsylvania Association of Environmental Professionals, announces the completion of several projects and activities intended to improve Montour Run and the well-being of communities located within it.

The fourth remediation system for abandoned coal mine drainage to be constructed under the sponsorship of the Montour Run Watershed Association (MRWA) in western Allegheny County was dedicated in ceremonies in November 2009.

The new system, designated as the McCaslin Road Mine Drainage Remediation Facility, is located on the property of Findlay Township's Department of Public Works near the intersection of Clinton Road and McCaslin Road just north of Clinton, PA. Construction of the McCaslin Road Facility is an outgrowth of the Montour Run Watershed Assessment and Cleanup Plan Project performed under MRWA sponsorship and funded by the Growing Greener grant program of the Pennsylvania Department of Environmental Protection (DEP). Conducted in the 2001-2003 time period, the assessment project sought to identify environmentally harmful discharges of contaminated groundwater from abandoned coal mines in the 37-square-mile Montour Run Watershed. It included a yearlong program of monthly sampling of these discharges, leading to recommendations for treatment approaches for the most damaging. A discharge from the Clinton Lake Mine complex along Clinton Road was identified as a significant source of pollution of the West Fork of Enlow Run due to elevated levels of acidity and aluminum.

This remediation system will improve the health of nearly two miles of the West Fork of Enlow Run. An estimated 14,000 pounds of acid and 1,700 pounds of aluminum will be prevented from entering the stream each year from this site alone. The resultant improvement in water quality will go far toward improved survival of fish and the aquatic life forms that support them.

The \$146,984 total cost of the McCaslin Road project has been funded through the DEP's Growing Greener program. In addition, matching cash, goods, and services valued at over \$30,000 have been provided by the prime contractor, BioMost, Inc., and its partners Quality Aggregates Inc., Stream Restoration Incorporated, and G&C Coal Analysis Lab.

Aside from acid mine drainage projects, the MRWA has been involved in outreach efforts. With the North Fork AMD Treatment site as an outdoor classroom, MRWA participated in an early summer training conference for environmental agencies from across the nation. MRWA also partnered with the Forest Grove Sportsman's Club on facilitating the installation of in-stream fish habitat improvements in the lower portion of Montour Run flowing through Club property.

The MRWA is a 501(c)(3) incorporated non-profit, chartered in the year 2000, which seeks to protect and improve water resources in the Montour Run Watershed. The North Fork Montour Run project is the third of four abandoned mine drainage treatment facilities fully funded to date for the Watershed. Other projects completed or in the planning stages include the Boggs Road, Clinton Road, and McCaslin Road Mine Drainage Treatment Projects. These projects implement recommendations of the River Conservation and Land-Use Plan for the Montour Run Watershed, established in 1998 by the Montour Valley Alliance, forerunner coalition to the MRWA.

Financial support for the MRWA is provided through memberships and donations from concerned citizens. Generous support is also provided by organizations and companies, including Dominion Resources, Inc. and the Western Pennsylvania Conservancy.

#### Portal to the Mining Industry

The costs involved with acid rock drainage (ARD) treatment continue to increase. While passive treatment has been a common treatment for ARD sources, it is not applicable for all sources, depending on water quality and flow rates. Limestone has been the primary alkaline source for passive treatment, but there is significant interest to find additional alkalinity-generating alternatives to avoid the need for active chemical treatment and the associated increase in operating and maintenance needs. With the potential to expand the applicability of passive treatment and develop a beneficial use of a waste material, Broad Top Township successfully applied for an innovative ex-situ treatment technology grant through the Pennsylvania Department of Environmental Protection Bureau of Abandoned Mine Reclamation to evaluate steel slag from an existing waste pile in Northeastern Bedford County, Pennsylvania, for ARD treatment.
